Rohini Marasinghe,J.

As conceded by the State the suspect had been in remand for more than 2 ½ years since 29.07.2010. The suspect had been in remand for more than 2 ½ years without even a charge being issued against him. Considering these facts we direct the High Court Judge to release the suspect, Saundige Siriyan on cash bail in a sum of Rs. 10,000/- with two sureties acceptable to the learned High Court Judge.

The suspect is directed to report before the Officer-in-Charge, Police Narcotics Bureau, Colombo 01 on the last Sunday of every month between 9 a.m. and 12 noon until the case is concluded.

Registrar is directed to forward a copy of this order to the Registrar, High Court of Colombo and to the Officer-in-Charge, Police Narcotics Bureau, Colombo 01.

The petitioner is entitled to a certified copy this order on payment of usual charges.
