The petitioner has not submitted sufficient material to support the contempt charges in this application. The independent material submitted is by an inspection by a Police Officer and the Police Officer's observation is not sufficient to support the fact that the 1st respondent operating or maintaining a medical institution or nursing home or pharmacy or channel consultation service or conducting any laboratory tests in the premises No.33, Main Road, Marawila. In fact the police officer who had visited there, had all opportunities to inspect the premises and report on this matter. But he has not indicated in his report the fact that the 1st respondent was operating or maintaining such activities in the said premises. The other document that was submitted is an
