**ORDER** 

We direct the learned Magistrate to release the accused Kuruppu Arachchige Saman Chinthaka Kuruppu on bail subject to the following conditions;

Heard both counsel in support of their respective cases. The allegation leveled against the suspect in this case is that he committed offences under sections 354, 380 and 374 of the Penal Code and section 44 (A) of the Firearms Ordinance.
