The plaintiff-appellant has filed this appeal against the judgment of the learned district judge dated 1 July 1996. On a reading of the caption, it appears that the 1st defendant is Asgar Brothers carrying on business at 73, Jayantha Weerasekara Mawatha, Colombo 10. The action relates to a lease agreement. In addition to the 1st defendant, the plaintiff has named two other parties as defendants in the case.

Even in the lease agreement the party who has taken the vehicle in question on lease from the plaintiff is mentioned as Abba Mohamed Thyoob carrying on business in partnership as ASGAR BROTHERS.

Upon the demise of the aforesaid Abba Mohamed Thyoob the plaintiff-appellant has now made an application to substitute the 3rd defendant-respondent Akbar Abba Mohamed in place of the deceased Abba Mohamed Thyoob. The application of the plaintiff-appellant has been vehemently opposed by the 3rd defendant-respondent on the basis that he is not a partner of ASGAR BROTHERS. The plaintiff-appellant is seeking to substitute the 3rd defendant-respondent in place of the deceased

Abba Mohamed Thyoob based on the ground that he is a son of the deceased.

The action in the district court has been filed against the 1st defendant-respondent not in his personal capacity but as a partner of the partnership carrying on business under the name ASGAR BROTHERS. In circumstances, the substitution sought by the plaintiff-appellant does not appeal to the proper in law. As such, the application to substitute the 3rd defendant-respondent in place of the Abba Mohamed Thyoob is rejected subject to the right to substitute the proper person as the legal representative of the 1st defendant-respondent.

There shall be no costs.
