# Rohini Marasinghe, J.

This is an application to revise the order of the learned High Court Judge dated 29th June 2012 wherein he had refused to grant bail. However learned State Counsel concedes that this suspect had been on remand for more than two years without She further concedes that being served an indictment. the suspect had no previous convictions. However learned State Counsel submits that the suspect had been in possession of 4.35 grams of hereon. Therefore, the quantity alleged to have been in possession of the suspect is considerably large. The State Counsel has no objection for bail being granted as the suspect has been in remand without any indictment being served on him for Considering the above facts we are of the view nearly two years. that the suspect should be released on bail.

Therefore we direct the learned Magistrate to release the suspect **Mohommed Nushad Mohommed Thauseer** on cash bail in a sum of Rs.100,000/- with two sureties acceptable to the learned Magistrate.

The suspect is directed to report before the Officer-in-Charge, Narcotics Bureau, Colombo 01 on last Sunday of every month between 9 a.m to 12 noon until the case is concluded or condition is varied by Court.

Registrar is directed to forward a copy of this order to the Registrar Magistrate's Court of Colombo and the Officer-in-Charge, Police Narcotics Bureau, Colombo 01.

The petitioner is entitled to obtain a certified copy of this order on payment of usual charges.
