We have gone through the petitioner's petition and submissions made by the both parties. In my view petitioner has established exceptional circumstances to release the suspect on bail. Learned State Counsel does not object to release the suspect on bail. Considering all these facts, I release the suspect on bail.

Court directs the learned Magistrate of Homagama to release the suspect namely **Dissanayakalage Manjula Nishantha Dissanayake** on bail subject to the following condition.
