Counsel for the 23(A) defendant- appellant submits that the 2<sup>nd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> plaintiff-respondents are dead. 2<sup>nd</sup> plaintiff-respondent had died on the 4<sup>th</sup> November, 1994.
