This matter was supported along with CA/114/2015 since the relief prayed for by both petitioners is similar in nature. Counsel appearing for the Respondents raised several objections for the maintainability of this application too. I have analyzed the said objections in my order in 114/2015 and given reasons for the rejection of such objection.

Petitioner to the present application is the Secretary to the Political Party which has got more than one half of members elected to the Uva Provincial Council.

For the reasons given in my order in 114/2015 I have decided to issue notices on the respondents but refused to grant interim relief. I have no specific reason to treat this application separately since the conduct of the 1^{st} and/or 2^{nd} Respondent to remove the 36^{th} Respondent who was the Chief Minister Uva Province and appointment of the 21^{st} Respondent as the Chief Minister is challenged in both-these applications ignoring the provisions of Article 154 F (4) proviso to the main sub Article.

I decided to issue notices on the Respondent in this matter too. Application for interim relief as prayed for in paragraphs h-k of the prayer to the petition is refused.
