Heard all counsel in regard to this application for notices as well as an interim relief to be granted. After considering the Written Submissions and documents tendered by both parties, we are of the view that there is an important matter to be decided in this case. In the circumstances, this court is satisfied that there is a *prima facia* case to be looked into, by this court.

We are of the view that at the same time, the Preliminary Objections could be considered after the Respondents file their Objections and the Petitioner files their Counter Objection, if necessary. When the arguments concluded, this court would be able to address all issues along with the Preliminary Objections and this application will be finally decided after considering all legal arguments raised by all parties.

Accordingly, we direct the registrar of this court to issue notices on all the respondents. We issue an interim order under prayer (d) of the petition dated 21.04.2023 until the final determination of this matter.

Registrar is further directed to serve a copy of the said interim order to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> respondents immediately via telephone, fax, email and courier service. The expenses of the communication should be borne by the Petitioner.

On the next date if all parties agree this matter can be fixed for argument straight away, if the respondents do not wish to file further objections and if they are willing to rely on the limited objections which they have already filed. In that case this matter could be concluded within 3 months from today.
